POLICE REPORT

PCSO Galley explained that monthly Crime Figures would no longer be presented at the Parish Council meeting. He would continue to report on trends for criminal activity within area.

PCSO Galley reported that PC Appleby was now on beat in Clowne. The Chairman looked forward to welcoming him to a future meeting of the Council.

A Member reported the problem parking @ The Green, Clowne (junction of entranced to Aldi car park). Parked vehicles were making access to & from the car park dangerous. PCSO Galley would address the problems with the nearby shops and ask for their assistance to deal with the issue.

Cllr Reid explained DCC Highways would be re-instating the double yellow lines in the near future.

The 'Shop Watch' initiative was now successfully in operation and this had resulted in a decrease in shoplifting activity. He also added that the CCTV cameras were now operational.

COUNTY COUNCIL REPORT

The Chairman welcomed Cllr Western to the meeting.

Cllr Western reported on an Emergency Temporary Road Closure for Harlesthorpe Ave Clowne 06/11/15 > 13/11/15 to facilitate gas mains relay works.

Cllr Western explained that DCC were moving forward with the plans for level access at the (railway bridge) Barton Street/Mitchell Street area. The Scheme would be out for local consultation shortly.

Cllr Western gave a lengthy and detailed report on the Devolution deal for Nottinghamshire and Derbyshire, which enable acquisition of more local level funding opportunities. There had been intensive negotiations with government. The process would ensure improvements and benefit the County. She added that Devolution would not save Derbyshire from the cuts already facing the Council Council.

PRESENTATION FROM HERITAGE HIGH SCHOOL - NAMIBIA PROJECT 2016

The Chairman welcomed students of Heritage High School to the Parish Council meeting. Several students from Heritage High School gave a very informative presentation on the Namibia Bound 2016. Six students presented the Council with exciting opportunity to travel And work in Namibia. The life changing project would give 5 students would join students from 5 other secondary schools from the Bolsover District and together the 30 students would represent the District of Bolsover and Derbyshire.

The students explained that they would travel to Namibia to work in a residential school, teaching children about healthy lifestyles and take part in supporting the construction of a play Ground.

Before they begin the expedition, each student was tasked with raising £1,500. Various events, fundraising activities, sponsorship etc. etc. have been the focus of fundraising for the Team, including a disco to be held at The Centre on Saturday 5th December.

The students thanked the Council for the opportunity to engage with Councillors and local Parishioners and to give their perspective on the future project.
